## Civil Liberties and the Election

Join us Monday, October 11, 2004, 7:30 p.m. at 700 Hartford Turnpike in Hamden

**Please notice the meeting date is a week earlier than usual!**

We are pleased to present the new Legal Director of the Connecticut Civil Liberties Union, Annette Lamoreaux, in a talk on "Civil Liberties and the Election," on Monday, October 11, in the main meeting room, following an informal half-hour for refreshments beginning at 7:30 p.m. (To accommodate Annette's busy schedule the regular Humanist monthly meeting has been moved to this night from the usual third Monday of the month.)

Previously while working for the ACLU of Texas, Ms. Lamoreaux represented (1) a death row inmate in suing the state court judge who refused to appoint his long time appellate lawyer to represent him at retrial, (2) a minor seeking release from custody to obtain an abortion, and (3) over a dozen Arab, Muslim and South Asian men during FBI interviews. A former staff attorney at the Texas Death Penalty Resource Center, she represented more than 35 inmates on death row, including one of the few men in Texas to be found too incompetent to be executed. Since coming to Connecticut she has been active in overturning unconstitutional local ordinances restricting political signs around the state. She speaks frequently on civil rights and civil liberties topics around the country.

Take Rt. 91 to exit 22 South, (Rt.9 S.) Take the first exit, #19, (CROMWELL WEST ST, Rt. 372). At the end of the ramp take a LEFT. Go past the first light, past a SONOCO gas station on your left. At the next light (about 0.3 mile from the exit ramp) take a LEFT to: WASHINGTON ST.
